3. Status of Land Acquisition

Final award for acquisition of land measuring 1750 Kanal 17 Marla for construction of the project has been issued by Collector, Land Acquisition, Kishtwar on 01.07.2017 for land and on 11.06.2019 for Trees and Structures. An amount of Rs 32.47Crores (26.94 Cr for land+5.53 Cr. for trees and structures) has been deposited with ACR (Collector Land acquisition) for disbursement to land owners and Rs. 30.42 Cr. has been disbursed so far.

4. Status of R&R Plan Implementation

R&R Plan has been approved by GoJK vide Government Order No. 11-DMRR&R of 2019 dated 07.03.2019 with the total amount of Rs. 9956.22 lacs.

An amount of Rs. 30 crores in two instalments has been deposited with Commissioner R&R. An amount of Rs. 17.58 Crores has been disbursed to the Project Affected Families so far.

5. Status of Infrastructure works

- i) All roads leading to major structures like Dam, DT, Power House, TRT have been completed.
- ii) Construction of benches for Site Office along with internal road work and protection work is in progress.
- iii) Letter of award to CWPRS was issued on 08.12.2016 for conducting Hydraulic Model Studies of the project. The same is in progress.
- iv) Construction of foundation/plinth work for temporary site offices near Dam site is in progress.
- v) Superstructure work for construction of temporary site offices of Sr. officers & other staff is in progress.
- vi) Construction of temporary residential infrastructure work- Development of Platform has been completed. Protection work is in progress.
- vii) Development of platform for 33 x 11 KVA receiving station- Development of Platform has been completed. Painting Work is in progress.
- viii) Water Supply Work: Final negative deviation is in process. Procurement of new pipes for distribution is in process.
- ix) Power Supply for Site Office: 11 KV line works and transformer erection completed. 11KV/415 Volt, 250 KVA transformer charged. Existing Site Office connected to Grid Power.






