Sealed Tenders are invited on behalf of CVPP from reputed Architects / Consultants for the below mentioned works for the construction of CVPP Corporate Office Building at Rail Head, Jammu **under Two-Envelope system** (Envelope No. 1 – Technical Bid and EMD & Envelope No. 2 – Price Bid) :

2. Period of sale of tender documents: 05.10.2012 to 15.10.2012 (10 am to 5.00 pm on working days)
Last date for submission of tender is 22.10.2012 up to 3.00 pm at CVPP Corporate Office, Jammu.
Date of opening: 22.10.2012 at 3.30 pm at CVPP Corporate Office, Jammu.

3. **Eligibility Criteria:**

The bidder must have following minimum criterion for bidding:

(A) **Technical Criteria:** Experience of having successfully completed the work of “*Consultancy services for Planning, Architectural and Engineering Designing, Estimation and Field Co-ordination Works of similar project for the following values during last 5 years ending last day of the month previous to the one in which application are invited should be either of the following:*

- i.) *Three completed works each costing not less than Rs. 20 Lakhs.*
OR
ii.) *Two completed works each costing not less than Rs. 25 Lakhs.*
OR
iii.) *One completed work each costing not less than Rs. 30 Lakhs.*

(Note: In case of evidence of work experience against qualifying requirement has been issued by non-governmental organization, copy of TDS issued by client/owner against the said work is required to be submitted by the bidder.)

(B) **Financial Criteria:**

Turnover: *Average annual financial turnover of consultancy works during last 5 years, up to year ending 31.03.2012, should be at least Rs. 50.00 lakhs.*

(Note: For bidder's financial evaluation, duly printed audited annual financial statement (balance sheet, profit & loss account/ Statement of income & expenditure, income tax return) for immediate preceding five years shall be submitted by the bidder. Where the turn-over is not bifurcated and revenue received from consultancy services are not available then the certificate from the auditor in respect of revenue against consultancy services needs to be furnished.)

(C) The Consultancy Firm/ Architect should be registered.

4. **Sale of tender document:** Intending firms may obtain the tender document from the office of **Chief Engineer (E)**, CVPP Corporate Office, Second Floor, JKPCC Building, Panama Chowk, Jammu 180 006, through person or post. Bidder may submit an application along with Bank Draft of requisite amount towards Cost of Tender Document (non refundable) in favour of Chenab Valley Power Projects Pvt. Ltd. payable at Jammu. Tender documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs. 500/-. The authority inviting tenders will not be held responsible for the postal delay, if any, in the delivery of the documents or non-receipt of the same.
5. In case the last date mentioned at Para 2 above is declared holiday, the next working day shall be considered as last date.
6. The tender for the work shall remain open for acceptance for a period of one hundred twenty days from the last date of submission of tender. If any bidder/ tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
7. The CVPP shall have the right to reject any or all the tenders or cancel the tendering process at any time before award of Work.
