Chenab Valley Power Projects Limited (CVPPL), is a hydro power generation company operating in the UT of J&K formed at the initiative of Government of India and Government of J&K to harness the vast hydro potential of river Chenab in District Kishtwar of J&K. The Company was incorporated on 13.06.2011 as a joint venture between NHPC Limited and JKSPDC Limited, with shareholding of 51% and 49% respectively. The Company is currently entrusted with the responsibility of developing four Hydroelectric projects (*Pakal Dul HEP-1000 MWs, Kiru HEP-624 MWs, Kwar HEP-540 MWs and Kirthai-II HEP-930 MWs*) on Build, Own, Operate and Maintain (BOOM) basis with aggregate generation capacity of 3094 MWs.

Kiru HE Project (624 MWs) is one of the four Projects of CVPPL that is presently under active construction. The Kiru HEP is a run-of-river Project proposed on river Chenab in district Kishtwar, of J&K. The Project envisages construction of 135 m high Dam and an underground Power House with 4 units of 156 MW each. The Project site is located about 42 kms from Kishtwar Town.

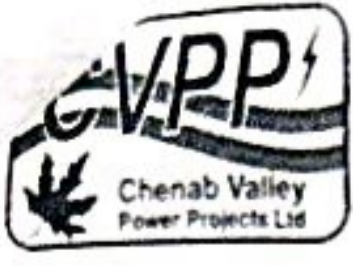
