One of the projects of CVPPL i.e. **624 MW Kiru HEP, located** at Pathernaki, Nagseni Block, district Kishtwar invites applications from qualified and authorized medical practitioners for engagement on **PART-TIME BASIS** for providing consultation to its employees at the Project Dispensary. Sl.	Description	Remarks
1	Notification for Engagement	This notification is being issued for engagement of 01 no. qualified medical doctor to provide consultation to the employees of Kiru HEP at Kiru site dispensary on per visit (of 02 hours) per day basis.
2	Job Description	The candidate shall be required to provide consultation to the employees of Kiru HEP at Dispensary of Kiru HEP located at Pathernaki, Nagseni Block, District Kishtwar (approx. 40 Kms from Kishtwar town) for 02 hours visit on each day (MONDAY TO SATURDAY). The candidate shall also be responsible for strengthening and improving the functioning of the Project dispensary.
3	Who can apply	Eligible and interested candidates having requisite Professional Qualification and experience can come for an interview / interaction at the notified date, time and venue. Shortlisted candidates shall be thereafter called for an Interview / Interaction on the notified date.
4	Age Limit	Candidates not more than 62 years as on 01.01.2025.
5	Min. Essential Professional Qualification	MBBS from a University / Institute recognized by MCI. The candidate must be registered and must possess a valid registration no.
6	Experience Requirements	Candidates having relevant work experience (excluding internship) shall be given preference. The cut-off date for consideration of experience shall be the date of issue of notification.
7	Tenure of engagement	This engagement shall initially be for a period of 01 year from the date of joining, which however may be extended thereafter, depending upon the performance of the candidate and the requirements of Kiru HEP.
8	Remuneration / Honorarium	The candidate shall be paid a lump sum, all-inclusive remuneration / honorarium of Rs. 2200/- (Rupees Two Thousand and Two Hundred only). This remuneration shall be per visit of 02 hours each day basis (Mondays to Saturdays). [Example: If the Doctor visits the Dispensary on all the days in a given calendar month of say 31 days that has 05 Sundays, then the gross amount payable would be Rs. 2200 (Rate) X 26 days (with visit of 02 hours each day) = Rs. 57200/-]. The actual payment shall depend on the no. of visits made during the month.
9	Payment and Taxes	Payment shall be made by Kiru HEP directly into the account of the candidate, as per applicable taxation norms.

10	Application Process	The interested candidates are required to fill in the application form (Annexure-I) and submit the same with HR Division, Administrative Building-CVPPPL Kiru HEP, Semna Colony, Kishtwar along with the self-attested copies of all relevant documents on or before the last date of receipt of applications i.e.22/02/2025 . The candidates are required to mention the notification no. at the top of the envelope. No other mode of application shall be entertained.
11	Selection process	The applications submitted by the candidates shall be scrutinized and the shortlisted candidates only, shall be called for an Interview / Interaction on the notified date. The interviews shall be conducted by the selection committee and on the basis of profile and performance of the candidate in the interview, the candidate shall be selected. For the purpose of shortlisting and finalization of the candidate factors such as <i>no. of years of relevant experience, location where the candidate is currently based, present engagement, age of the candidate etc. shall be taken into account</i> . Candidates belonging to the families affected by CVPPPL Projects (PAFs) shall be given preference.
12	Letter of engagement on part time basis	Once the committee recommends the candidate for selection, a letter of engagement shall be issued accordingly, thereafter.
13	Miscellaneous	For the purpose of release of payment, the selected Doctor shall submit his bill, each month, and after verification of attendance and other details, the bill shall be released accordingly on the basis of the actual visits (each of 02 hour) made.

14. Other conditions:

- The Candidate must be an Indian National possessing requisite qualification from an Institute recognized by MCI or having valid practitioner license.
- The candidates shortlisted for the Interview / interaction on the notified date, time & venue are required to bring along the following documents (original and one set of self-attested photocopies):

 - Pass certificate and mark sheets for educational qualification.
