Chenab Valley Power Projects Limited (CVPPL) - A Joint Venture of NHPC Limited (A Govt. of India Enterprise) holding 51% stake & JKSPDC (A Govt. of J&K Enterprise) holding 49% stake was incorporated on 13.06.2011 to harness the vast hydro potential of river Chenab in Kishtwar district of UT of Jammu & Kashmir. The Company is currently entrusted with the responsibility of developing four Hydroelectric projects on Build, Own, Operate and Maintain (BOOM) basis with aggregate generation capacity of 3094 MW.

Pakal Dul HE Project (1000 MW) is one of the four projects being developed by CVPPL in Kishtwar. The project envisages construction of a 167 m high Dam on Marusudar, tributary of river Chenab, in Drangduran area, an underground Power House with 4 units of 250 MW each in Arzi village. The damsite is about 45 kms away from the district township of Kishtwar and the Power House is about 25 km.

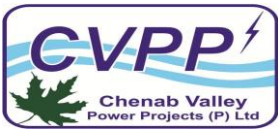

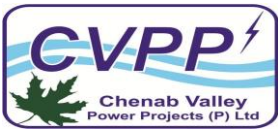
